December 10 Luncheon Holiday Program: Liberty Park Middle School Choir

The Liberty Park Middle School Treble Choir is made up of 7th and 8th grade female students. In the context of a non-auditioned treble choral ensemble, the students become musically independent in the areas of reading music, aural skills, choral blend, composition, performance etiquette, and appreciation of treble choral literature through theory study and performance. Special attention is placed on the development of the adolescent female changing voice. These students perform at the LPMS winter concert, spring concert, various school assemblies, and one adjudicated state-level assessment each year. Six of these ladies were just selected by audition to sing in the 2025 Alabama All-State Choir.

takes us. That mission starts right here in Vestavia.

Shades members serve our community in many ways, most notably through our schools and in our police department. We have four School Care Teams that provide support and encouragement to the teachers and staff members at Vestavia Hills Elementary East, West and Dolly Ridge schools and at Pizitz Middle School. Our families also open their homes and host Cop Stop meals for our police officers every month.

This year is our second year of our Gift of Hope initiative. Through the Gift of Hope campaign we seek to help provide Christmas gifts for families in need through our local schools. Last year we served over 125 families and we anticipate serving even more this year. In addition to clothing articles each recipient will get an age-appropriate hygiene kit, a Christmas stocking and a bible.

We are also proud to support the Vestavia Hills Chamber of Commerce by sponsoring several community events including the Dogwood Prayer Breakfast and I Love America Night. Shades has also served as a sponsor of the Vestavia Hills Police Foundation's Community Night Out event.

SELECTING AND ELECTION OF DIRECTORS AND OFFICERS

Article IV - Section 2

A. Nominating Committee: At the regular August meeting of the Board, the Chairperson shall appoint, subject to approval by the Board, an Ad Hoc Nominating Committee consisting of five (5) Members of the Chamber.

- (a) The Nominating Committee members shall be the current Chairperson of the Board, the current Chairperson-Elect of the Board, One (1) Director or Officer, and two (2) Members at large.
- (b) The current Chairperson-Elect shall serve as the Chair of the Nominating Committee.
- (c) The President shall serve in an advisory capacity to the Nominating Committee.
- (d) The Nominating Committee shall present to the Board for approval prior to October 31, a slate of candidates to serve as Directors and Officers of the Chamber for the following year. Each candidate must be a Member in good standing and must have agreed to accept the expected responsibilities.

B. Publication of Nominations: Within ten (10) days of receipt of the report of the Nominating Committee, the Chairperson shall give Notice to the general membership of the names of persons nominated as candidates for Directors and Officers and the right of petition as contemplated in these Bylaws.

C. Nomination by Petition: Additional names of candidates for Directors and Officers may be nominated by a petition bearing the genuine signatures of at least fifteen (15) Members of the Chamber. Such petition shall be submitted to the presiding Chairperson within ten (10) days after Notice has been given of the original nomination as contemplated in Article IV(2)(B). The determination of the Board as to whether the petition(s) complies with these Bylaws for consideration shall be final.

D. Determination: If no valid petition is properly submitted within the designated period, the nominations shall be closed and the nominated slate of candidates shall be declared elected by the Board of the Chamber at the November Board Meeting, regardless of whether a Quorum is present at such meeting.

If a valid, proper, and legal petition shall present additional candidates, the names of all candidates shall be arranged on a ballot in alphabetical order and applicable instructions for voting will be included. The Chairperson shall give Notice of this ballot to all Members within twenty (20) days of receipt of the valid, proper, and legal petition.

The ballots shall be marked by the Members in accordance with the voting instructions printed on the ballot and returned to the Chamber's office within ten (10) days of the date of the ballot. The members of the Chamber shall, at their Annual Meeting, declare the candidates with the greatest number of votes elected.
